Definitions

Minimum Charge	A minimum charge (\$302 + a \$55 System Access Fee) will be charged to students who cancel their registration in this session in a degree or non-degree program on or after the published date for the first day of classes for the Summer Session.
Incidental Fees	Compulsory fees for campus and student services.
Ancillary Fees	Compulsory fees charged for specific courses or programs (e.g. laboratory fees.)
System Access Fee	Compulsory fee for access to ACORN.
