- 3. students who are enrolled in a Computer Science Major/Specialist program, or a Data Science Specialist program or a Bioinformatics & Computational Biology Specialist program and who are registered with <u>Accessibility Services</u> <u>and</u> who are recommended to take a reduced course load as a learning accommodation will be billed Course Fees for a course load up to a maximum of 4.5 credits in accordance with <u>Table 3C</u>.
- 4. <u>Monthly service charges</u> are calculated on unpaid Fall Term fees in October, and calculated on unpaid Winter Term fees in December.
- 5. There may be additional <u>ancillary fees</u> levied for enrolment in specific courses or for individual circumstances. Check your invoice on ACORN.
