#### **Final Year Domestic Doctoral Students - After Time Limit**

**Final Year Program Extension Fees for Domestic Students including:** 

- a) PhD Students who began their Program after September 1, 2010 and Current, Registered Students who "opt-into" the New Program Extension arrangement
- b) All Other Doctoral Students who were registered Full-time the year prior; began their Program after September 1, 2011 and Current, Registered Students who "opt-into the New Program Extension arrangement

Refer to Domestic Final Year - Before Time Limit Fee Schedule if:

- a) PhD Students on a program extension who began their Program prior to September 1, 2010 who did NOT "opt-into" the New Program Extension arrangement.
- b) All Other Doctoral Students on a program extension who were NOT registered Full-time the year prior and/or began their Program prior to September 1, 2011 and did NOT "opt-into" the New Program Extension arrangement.

Academic fees for international doctoral students in the final year of their program (after time limit) are pro-rated based on the twelve-month academic year. Incidental fees are charged on a sessional (term) basis. Doctoral students will be billed for the whole year but may choose to pay:

- 1) the full fee.
- 2) the minimum first payment (as indicated on the fee invoice format on ACORN) or
- 3) the fee based on the expected date of completion.

Note: A minimum charge of \$338.00 will be charged to students who cancel their registration in this session in a program (degree or non-degree program) on or after the published date for the first day of classes for the Fall-Winter session.

Incidental fees include mandatory fees for University services and student society services.

If you choose to pay less than the full-year fee, please note that starting October 15th, a monthly service charge at a rate of 1.5% compounded (19.56% per annum) will be applied to any outstanding Fall term fees, and starting December 15th, a monthly service charge at a rate of 1.5% compounded (19.56% per annum) will be applied to any outstanding Winter term fees.

When degree requirements are complete, the Student Accounts Office will be notified of the completion date and will adjust the fees accordingly, including service charges to outstanding balances that have accrued since October 15th.
