IMPORTANT NOTES:

Note 1	If you cancel your last course and your registration in the session a minimum charge of \$409.75 (which includes a \$61.75 system access fee) will be charged to students who cancel their registration in a program (degree or non-degree program) on or after the published date for the first day of classes.
Note 2	This refund schedule applies to courses offered at the Faculty of Arts & Science

Note 3

The last date to cancel a course or registration with no [academic penalty](#) may not always be the same as the last date to be eligible for a refund.

Category 2A	Incidental Fees – Compulsory Campus and Student Services Charges reversed only when registration is cancelled. Students’ final incidental charges will be determined either after the last day to add F+Y courses in May or after the last day to add S courses in July (<i>only</i> if enrolling in courses in the second half of the Summer term). Students who are enrolled in 1.5 – 2.0 credits are considered full-time and will be charged full-time incidental fees for the academic session. Students who are enrolled in 1.0 credit or fewer are considered part-time and will be charged part-time incidental fees for the academic session. [Note 1]
